SELECTION PROCEDURE

1. The recruitment process may consist of: **Written Test and/or Presentation and Interview**. The Selection Committee reserves the right to devise the criteria for recruitment based on the number of applications received.
2. It is mandatory for the candidates to appear in person for Technical Presentation and Interview.
3. Facility of Technical Presentation and Interview through video conferencing for candidates residing abroad is available at their own risk as Institute is not responsible for any technical glitches such as related to internet connectivity etc resulting in failure to appear before the presentation/ selection committee.
4. Based on the recommendations of the selection committee and approval of the Board of Governors, appointment letters shall be issued.
5. Institute reserves the right to cancel /restrict/ enlarge/modify/ alter the Recruitment Process, if need arises, without issuing any further notice or assigning any reason, therefore.

General Instructions

1. The appointment of Assistant Professor at Level-10 is on contract for 3 years extendable by 2 years with all service benefits as applicable to regular employees.
2. Applicants seeking reservation benefits for SC, ST, OBC (NCL), PwD and EWS must be in possession of the certificates in the format prescribed by the Government of India in support of their claim at the time of application.
3. The number of vacancies indicated in the notification is tentative. IIIT Agartala reserves the right to increase or decrease the number of advertised posts at the time of selection. Further, IIIT Agartala reserves the right not to fill any of the posts advertised.
4. The appointment of the selected candidates is subject to being found medically fit as per the requirements of the Institute.
5. The person employed on regular employment in Government and Semi-Government Organization, the public sector, Autonomous bodies of Govt. of India, or state government must apply through the proper channel. In such case, the candidates are advised to send an Advance copy which should

reach before 18.09.2026. In such cases, the applications are required to bring a **No Objection Certificate (NOC)** from his/her employer at the time of appearing at interview.

Application Fee

Candidate should pay a non-refundable application fee through online payment mode at the time of final submission of the application as below:

- For the candidates other than SC/ST/PwD category: INR 2000 (Rupees Two thousand only)
 - For SC/ST category: INR 1000 (Rupees One Thousand only)
 - PwD category : No fee is required.
- The fees should be paid online through the application portal by Net Banking/Credit/Debit Card as per the details given in the payment link.
 - Application processing fee once paid will not be refunded under any circumstances.

Submission of Documents/Certificates

1. The self-attested copies of the following documents are required to be attached with the downloaded Application Form failing which the application shall not be evaluated and shall stand summarily rejected:
 - a) The hard copy of the prescribed application form, duly signed on all pages.
 - b) 10th Certificate.
 - c) 12th Certificate.
 - d) Graduation mark sheets for all years/semesters.
 - e) Graduation degree certificate.
 - f) Master's degree and mark sheets for all years/semesters.
 - g) Ph.D. award certificate / provisional award certificate (notification)/ Submission certificate (Notification).
 - h) NOC from the current employer (if any) (Required at the time of interview).
 - i) EWS and OBC-NCL Certificate (wherever applicable) issued in the current Financial Year (i.e., issued after 1st April 2026) only as per Central Government Format.
 - j) Caste Certificate for SC/ST/ candidates as per Central government Pro forma
 - k) PwD Certificates (wherever applicable) in prescribed pro-forma of Central Government Only.
2. Submission of application, Possession of essential qualification and experience does not provide right to be called for interview. If a candidate is called for test/ presentation/ interview, he/she will not get any right for selection and appointment. There is no system or practice to send any written communication to candidates not called for interview or who are not selected after test/ presentation / interview, indicating the reasons for rejection. The Institute has the option to limit the number of candidates to be called for interviews considering number of positions to be filled in, specialization requirements, subject discipline, etc.
3. **Incomplete application without self-attested copies** of relevant certificate(s)/document(s) are liable to be summarily **rejected**. All the details furnished in the application will be treated as final and no changes will be entertained. The responsibility of entries in the application form lies with the Applicant.
4. Applicants are advised to mention their correct and active email ID in the application, as all

the correspondence like issuance of call letter or any other information will be communicated through email only.

5. In case of any corrigendum/addendum pertaining to this advertisement, it will be published in the Institute's website only. Accordingly, all applicants in their own interests are advised to keep track of Institute website.
6. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the applicants.
7. The Institute will verify the antecedents or documents submitted by a person at the time of appointment or during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake, or the person has a clandestine antecedents or background, and has suppressed the said information, then his/her services shall be terminated forthwith, and legal action may be initiated against such candidates/employees.
8. No interim correspondence whatsoever will be entertained from candidates regarding conduct and result of test/interview and reasons for not being called for test/interview as applicable.
9. No TA/DA and/or Lodging/ Boarding will be paid to the candidates called for written test/ presentation/ Interview.
